THE 'DEAD MAN'S PENNY' THAT HIS NAME NOT BE FORGOTTEN

They thought it would be over by Christmas. But Christmas 1914 came and went yet still the fighting continued. The Great World War for Civilization had begun and it would be a war unlike any that had come before. Few would be spared from loss and grief.

Among the collections of the RCMP Historical Collections Unit (RCMP HCU) sits one of the tangible reminders of that loss: the Memorial Plaque, often called the "Dead Man's Penny" by the soldiers themselves.

In October 1916, as some of the worst fighting of the war was taking place on the Somme, a committee was struck to consider the matter of a memorial for the next of kin of the fallen. By August 1917 the "Times" was announcing a public competition to decide the design of the committee's proposed commemorative bronze plaque.

The response was beyond anyone's expectations. Over 800 entries came in from across the British Empire, the Dominions, the Western Front, and the

Balkan and Middle Eastern theatres. So many serving soldiers entered the competition that the committee had to extend the deadline. In the end, Edward Carter Preston of the Sandon Studios Society, Liverpool took first prize.

Twelve centimetres in diameter, the round medallion is dominated by the figure of Britannia, her head bowed respectfully towards the rectangular tablet bearing the name of the deceased. No ranks were used. All were equal in making the supreme sacrifice. In her left hand Britannia holds a laurel wreath, symbol of victory. Around her appear two dolphins, symbols of Britain's sea power, and in the foreground, a lion "striding forward in menacing attitude" to represent Britain's strength. In the exergue, a second British Lion symbolically pounces on German Imperial Eagle.

Production began in December 1918, at first in a disused laundry in Acton, West London, then at the Woolwich Arsenal factory. Over time a number of disused armaments factories were used to make the medallions. It is not recorded what the families thought of this ironic, albeit practical, decision. Originally, the British Government had planned on needing only 800,000 plaques. In the end, they issued 1,150,000 (600 honouring women) and used 450 tonnes of gunmetal to do so. Even so the scheme ended before all the fallen could be recognized.

The Memorial Plaque in the RCMP HCU collection was issued in honour of James Alexander Burke (Reg. No.3101). Burke was no stranger to the Mounted Police. His father, Patrick "Paddy" Burke (Reg. No.402) served as a Trumpeter during the North West Rebellion, succumbing to wounds received in May 1885 during the Battle of Cut Knife Hill. James' brothers, Patrick (Regt No.3124), Joseph (Reg. No.2814) and Frederick (Reg. No.3196) all served -- even his sister married a member.

James joined the Force for a short time as a Special Constable before being engaged as a bugler in 1894 at the age of 15. He joined the Canadian Mounted Rifles in 1899 and served during the South African War, returning to Canada and the North West Mounted Police in 1901. He was transferred to Whitehorse in 1901, returned to Regina, spent a short time at Prince Albert before returning once again to Regina. The South African War seems to have left James troubled. A mounting number of infractions appeared on his record following his return

from overseas. By 1904, he was dismissed from the Force after ten years service.

It's not entirely clear what James did after leaving the Force. When he joined the Canadian Expeditionary Force (CEF) in 1914, he listed his occupation only as "laborer" a common practice at the time and one that covered a wide variety of occupations. But it was clear that his previous overseas service and his years with the Force made him a valuable recruit for the CEF. He was quickly accepted into the 6th Battalion, CEF and en route to the battlefield of Europe.

During the fighting, James Burke was wounded during a gas attack. He survived the attack itself, but as was so often the case, the gassing had lingering effects. Burke was declared unfit for further duty and returned home for treatment at the Military Convalescent Hospital at Saskatoon. He died on August 17, 1917 and was laid to rest in Battleford, Saskatchewan.

Readers offer new and interesting information regarding LEGACY OF THE DOLLS and Cst. Ross Gibson. FRIENDLY NOTES, VOL.20,ISSUE 2,SPRING 2010

Good Morning,

I found Barry and Pat Nowell's account of their trip to B.C. and subsequent encounder with Hank and Sylvia Graber most interesting. That the Graber's would donate the two dolls and accompanying letters to the Museum is a kind and generous offer.

What was not included in Barry's background on Cst. Gibson and something that your readers might be interested in is Gibson's involvement in a significant period in Canadian, Force and Inuit history.

From the late 1930's through to the early 1960's the Canadian Government embarked on an initiative to relocate Inuit families within what was then the Northwest Territories to areas where better services could be provided or where better hunting conditions might exist.

One of these relocations occurred in the early 1950's when several families from Port Harrison (now Inukjuak) Quebec were moved to locations in the high arctic, specifically Resolute Bay and Bache Peninsula/Grise Fiord. The reasons for these moves was to alleviate what was perceived to be a significant decline in available wildlife for food in northern Quebec.

Rightly or wrongly the moves were undertaken and Cst. Gibson, then stationed at Port Harrison, Quebec was ordered by the CO of "G" Division, Insp. H. Larsen, to assisted in the selection of several families and then accompany them to Resolute Bay where he remained for upwards of 2 years.

The relocation of these families continues to resonate throughout Canada and much has been written about the reasons for the moves. Regardless of the governments rational Cst. Gibson and other members of the Force undertook to perform their duties, living with the Inuit in a new land and facing new challenges together. From most accounts members of the Force, including Cst. Gibson performed those duties well.

Readers of *Friendly Notes* interested in learning more about these moves might like to consider the following books; Relocating Eden by Alan Rudolph Marcus, Tammarniit (Mistakes), Inuit Relocation in the Eastern Arctic 1939-63 by Frank James Testor and Peter Kulchyski and (my favourite) Arctic Smoke and Mirrors by Gerard Kenney. Mr. Kenney goes so far as to dedicate his book to Cst. Gibson.
