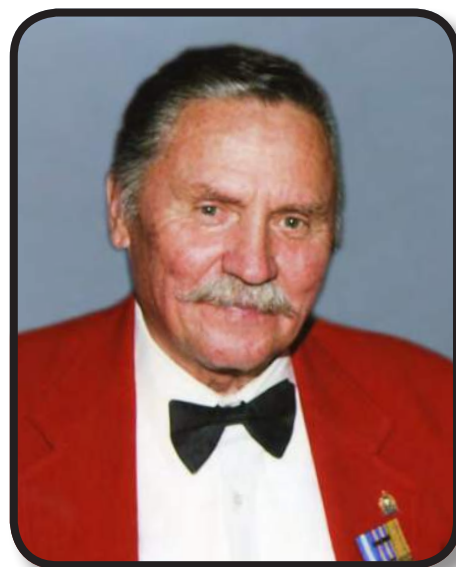

## *The President's Report*

Again it is my pleasure as President of the *Friends of the Mount Police Heritage Centre* to present the 2014 President's Report.

Our core function is to do all we can to support programming, education and historical collections at the RCMP Heritage Centre, thus enabling it to carry on the vision of commemoration and sharing the story of the RCMP to the world. 2014 marks a quarter of a century that we have worked towards this end, past and current members.

With this in mind, it is with sadness I report the loss of individuals who led the way and/or played key roles for us. Tom Light, who served as President of the *Friends* for eight years; John Worthington who served for many years on the Boards of both the Heritage Centre and the *Friends*; and Tony Brezinski a past Director of the *Friends*. Our thoughts and prayers go out to their families.

This past year proved to be interesting and challenging. We saw an increase in our overall revenue which can be attributed to two key areas. First, we were able to finally get our cheque insert/mail out campaign done in the last quarter of the year which resulted in more than 300 new members of the *Friends*. I welcome each of you to our family. The second contributing factor was a significant increase in the Cadet Troop load for 2014. Increased cadet usage of the washers and dryers in the dorm buildings resulted in a substantial increase in revenue for us.

Mosaic made a substantial donation to the Heritage Centre and included therein was a unique challenge to the *Friends*. Mosaic is prepared to match the *Friends'* contribution to the Heritage Centre over a five year period to a total of \$220,000.00. The limit set for 2014 was \$35,000. We rose to and exceeded that amount. For 2015, Mosaic has set their matching contribution target to be \$50,000.00. With your continued support and efforts we are confident to reach that milestone.

To qualify as a Life Member an individual had to have made an overall contribution \$1,200.00 to the *Friends*. This year we were pleased to welcome 27 new Life Members.

As members of the *Friends* and if not yet done so, I encourage you to consider becoming involved in activities at the Heritage Centre. I also ask you to reach out to your immediate circle of friends. Those who may be looking to support a not-for-profit organization or charity in your communities. Have them look to the Heritage Centre, either directly or through the *Friends*, as their primary area of interest. We are always looking for support and volunteers.

In closing I wish to again recognize the strong working relationship and partnership between Heritage Centre employees, those who work in Historical Collections and the *Friends*. Together we make a strong, formidable team that can rise to any challenge.

## RCMP Heritage Centre Report – 2014 in Review

In last year's report, I asked you to "*stay tuned*" for some exciting announcements in 2014. That first announcement came with the very generous donation of \$1,000,000 from The Mosaic Company at a major media event in April. The Mosaic gift is designed to help us "grow the experience" in on-site programming and community outreach.

Included in this major donation was a very unique component we like to call the "Mosaic Challenge"; the setting aside of \$220,000, to be drawn down annually over five years, matching dollar for dollar (to a set but increasing maximum) what the *Friends* project to donate to our cause in each of those years. The *Friends* have met the maximum to date, and have actually exceeded adding significant value to their contribution. The Mosaic challenge not only benefits us right now, it also serves as a tangible testament to a quarter century of uninterrupted financial and volunteer support provided by the *Friends*.

Right on the heels of that announcement, and in conjunction with the Force's birthday in May, the Regina Hotel Association (RHA) announced their \$95,000 sponsorship of the new "People Movers" or electric trams we unveiled that day. These environmentally friendly vehicles, sometimes referred to as golf carts on steroids, enabled us to further "enhance the experience" by touring people through the grounds here at the home of the Mounted Police, comfortably, effectively and efficiently. The People Movers have proven to be a popular and much appreciated option to the standard walking tours.

In May we also formally recognized and expressed our gratitude to Mosaic and the RHA for their valuable contributions, as well as eleven other donors, with the unveiling of granite plaques on our "Donor Wall" in the Regimental Lobby. The list of recognized Donors included a nice mix of public and private entities as well as individuals contributing \$5,000 or more directly to the Heritage Centre. We were thrilled to have Commissioner Bev Busson (Retired), on hand to help honour those who support us so generously.

Commissioner Busson, who was a member of Troop 17, 74/75, the first female Troop, also honoured us by officially opening our feature exhibit celebrating "40 Years of Women in the RCMP". This interesting display ran through the busy tourist season and was followed by an exhibit developed by the Nikkei National Museum, titled "A Call for Justice" which opened at the Heritage Centre in October. The RCMP Heritage Centre was the first organization to host this exhibit after the inaugural showing at its home base in British Columbia. We were honoured to partner with the Regina Japanese Canadian Club, making Regina the first city to host this travelling exhibition. In December we extended its stay for an additional three months, until the end of March 2015.

We also hosted the simple but powerful "Faceless Dolls" exhibit, originally created by the Native Women's Association of Canada and recreated by KidsFirst Regina who we partnered with to help increase awareness of the 1,281 missing and murdered aboriginal women in Canada. Our total admissions grew 14% over the previous year with a significant increase in school and group visitations.

Our regular school programming continued to grow again this past year in response to our improvements and additions. We hired extra summer students to assist with our new “people mover” driving tours as well as the walking tours. We also brought on two students to look after and ride (wearing replica NWMP uniforms) the two retired musical ride horses stabled at “Depot”. They participated in additional community outreach events and parades, including the North American Indigenous Games opening ceremonies and the WWI commemoration ceremonies at the War memorial located at the Saskatchewan Legislature.

Our Arctic Adventures program in February has continued to attract more and more people and for the first time we brought on a sponsor, Cabela’s. Our Heritage Christmas program this year saw the largest turnout for a single day event since the Heritage Centre opened on May 23, 2007, with well over 700 people in attendance. We are unsure if the increased traffic was because of the visit by Mrs. Claus or the free reindeer pancakes.

The “Play for Peace” program sponsored by Scotiabank saw its largest attendance since it was implemented in 2011. Our 2nd annual “Rough Rider to Roughrider” Regimental Dinner more than doubled in size in 2014, requiring a move to the Drill Hall at “Depot”. It was very successful and we were excited to have Mosaic take on the role of presenting sponsor, in addition to their big gift.

Retail sales are bucking the national trend, improving year over year at both the “Depot” Trading Post and the Central Trading Post gift store at the Centre. Once again we were awarded with a 4.5 rating from Trip Advisor. Our fans on Twitter have grown 39% over last year and Facebook followers grew by 14%.

Overall 2014 was a very good year for us as we continue to “grow the experience”. That does not mean we are content but it does mean we are moving forward and growing.

We are growing, in no small way because we have a great story to share, a good product we can improve upon, a growing and expanding base of generous sponsors and donors who are interested in helping us share this unique Canadian story.

Finally, we are succeeding thanks to you, our volunteers and members of the *Friends of the Mounted Police Heritage Centre*. Your generous contributions of time, talent, and treasures are really the core of what makes the Heritage Centre work and the effort worthwhile.

## *From the Managers' Desk – RCMP Historical Collections Unit 2014 Report*

We would again like to acknowledge the very important role the *Friends* play in the preservation and protection of our story as supporters of the RCMP's Historical Collection.

2014 has been a relatively quiet year in terms of reaching out to the *Friends* for assistance. Our feature gallery exhibit "40 years of Women in the Force" did not require a financial contribution. The work was performed in-house with existing resources and materials. Our work on the new 'Musical Ride Exhibit' has been financed through a sponsorship deal negotiated by the RCMP Heritage Centre.

The Unit received several new donations in 2014. They include printed media, paintings, photographs, and tactile items. The collection of new donations, and the costs associated, has been managed from within the Unit's own budget. On the horizon for 2015 though, is the partial refurbishing of the 1967 Cadillac which has been stored on the Depot grounds for the past 20 plus years. This custom vehicle is armour plated and has bullet proof glass. It was purchased by the RCMP to provide protective services for visiting dignitaries and Canada's Prime Minister. Eventually it was rotated out of operational service and acquired by the RCMP Museum. It is our hope to have this unique re-painted vehicle placed on display within the Heritage Centre gallery. The *Friends* have offered to pay for this work and the process is ongoing.

Two very significant events occurred in the Unit in 2014. The first was the retirement of Wendy Kraushaar from her position as the Historical Collections Assistant. Wendy enjoyed 25 years with the Royal Canadian Mounted Police Depot Division. She now contributes to the success of the Heritage Centre in her part time role as Coordinator of Volunteers. We have hired Thelma Brown as the new Assistant. Thelma comes to us from "F" Division. Secondly Rhonda Lamb, the substantive Manager of the Historical Collections Unit (HCU), is taking leave to deal with a serious medical concern. This has provided me with a terrific opportunity to work in the Unit. I thank the employees of the HCU, the staff of the Heritage Centre, and the *Friends* for making my experience here exciting and informative.

We are extremely grateful to the *Friends* for their ongoing support of the Collection and the work that we are doing to preserve and care for the RCMP's history. It is greatly appreciated by the Force overall and by our Unit in particular. Thank you for your generosity and support.

## *Twenty-Fourth Annual General Meeting*

The Twenty Fourth Annual General Meeting (AGM) of *The Friends of the Mounted Police Heritage Centre* was held in Regina, Saskatchewan, on Wednesday March 26th, 2014, in the Heritage Room at the Heritage Centre. The meeting started at 6:10 PM.

Fifty persons were in attendance at the meeting, and the President was in possession of 401 proxy votes.

Regrets were received from the Commissioner; Assistant Commissioner Butterworth-Carr, C.O."F" Division, and Jean Freeman, long-time member of the *Friends*, and actress with "Corner Gas".

President Bob Smart welcomed all guests, particularly Assistant Commissioner Louise LaFrance, C.O. "Depot" Division; C/Supt. Kevin Jones, representing C.O. "F" Division; Al Nicholson, CEO RCMP Heritage Centre; staff members of the Heritage Centre; and other honoured guests – Jean Thue, widow of Ivan Thue, one of our founding members; Malcolm Wake, former curator of the museum, and a founding member of the *Friends*; Doreen Light, wife of Tom Light, past president; Murray Grant and Willem de Lint, long-time members and regular attendees; Jim Sutherland of Winnipeg, a member of the *Friends* who travelled to Regina to attend this meeting; Steve Smedley, Director, who is leaving the Board this year, but who will continue with his "cheque insert" project; and Lorna Loftus, perennial best volunteer at the Heritage Centre.

President Bob called on Al Nicholson, CEO of the Heritage Centre; Rhonda Lamb, Manager of the Historical Collections Unit; and Barrie Nowell, Editor of the *Friendly Notes* and Annual Report. Al gave a brief, but quite comprehensive report on the activities of the Heritage Centre during the year, and the many upcoming events planned for the near future. Of particular importance was his success in bringing some financial stability to the operation, particularly with the City of Regina, the Province of Saskatchewan, and the federal government, and the RCMP, stepping up with financial support. He mentioned several announcements that will be forthcoming in May 2014, and commented on the "matching program" with Mosaic company. Al also mentioned the corporate membership program which hopefully, will attract members and memberships. Rhonda thanked the *Friends* for six years of assistance, particularly mentioning, the refurbishing of the painting "Beyond the Law", financed by the *Friends*, and the purchase of the George Hunter collection of photographs along the MacKenzie River in the early 1920s. Barrie reviewed the recent quarterly newsletters, and annual report.

## Farewell to Tom Light

Retired Chief Superintendent Tom Light, Regimental #O.605, passed away in Regina on November 25, 2014.

Tom joined the Force in 1948 at the age of 19. Most of his 35 years of service was in “F” Division (Saskatchewan) or “D” Division (Manitoba). He was commissioned in 1966 and transferred to “D” Division as Staffing Officer for 3 years and then as Detective Inspector for 4.

Tom returned to “F” Division where he served as Officer Commanding Saskatoon Sub-Division; Officer Commanding Prince Albert Sub-Division; and, finally C.I.B. Officer at “F” Division HQ in Regina. He retired in 1983 with the rank of Chief Superintendent.

Tom joined the *Friends* in 1993, serving as a Director until March 1999 when he was appointed President of the Board. On December 31, 2007, Tom suffered a stroke and resigned his post.

The *Friends* was Tom’s passion and many major accomplishments occurred during his time on the Board. As President, Tom, was the guiding force and an active participant in the planning and design of the new Heritage Centre, the transfer of horse program and gift shop operations to the Centre, and the *Friends*’ move from the museum to the new facility.

Tom was an avid fisherman, hunter of geese, pheasants, and upland game, and built his summer cottage on Nemeiben Lake, an isolated lake some 40 miles north of La Ronge, SK (accessible only by boat).

As well as a man of accomplishment, Tom was a man of impeccable integrity and honesty. He will always be remembered, and will be truly missed.

## *The Passing of John Worthington*

Retired S/Sgt. John Worthington, Regimental #21011, passed away on January 18, 2015 in Regina.

John was born at Timmins, Ontario and raised on a farm at R.R.#1 Oakville, Ontario. After finishing High School, he joined the RCMP on July 16, 1959 in Toronto, Ontario and was posted to “N” Division in Ottawa, Ontario for basic training. Upon graduation in May of 1960, he was posted as a percussionist to the Regimental Band of the RCMP in Ottawa. He remained and played with the Band touring Ontario, Eastern and Western Canada twice, as well as the Eastern U.S. States as far south as Boston. In September of 1964 he was transferred to North Battleford, SK, to General Police Duties. Later in December of 1964 he was transferred to Lloydminster, SK, on to City Detachment where he remained for 2½ years until moving on to Rural Detachment and Highway Patrol. His marriage to Judy who he met when she was employed by the CIB Branch for the Force in Ottawa, took place in Ottawa in June of 1965. In June of 1969 he and his family were transferred to Cumberland House Detachment where he was the N.C.O. I/C.

In June of 1971, John and his family were transferred to Regina, SK where he became the Federal Coordinator of the Migratory Bird and Small Vessel Regulations Section, for the Province of Saskatchewan. In April 1973 he was transferred to Regina Sub-Division as the NCO in Charge of Regina Custom and Excise Section for Enforcement in Southern Saskatchewan. In May of 1976 he was transferred to Regina GI Section and in June of 1976 was promoted to the rank of Sgt. In July 1978 he was promoted to the rank of S/Sgt. after having been temporarily transferred to “F” Division Headquarters, as the Assistant Security Coordinator for the Royal Visit to the Province in that year. At the completion of the Royal Visit he was transferred to a newly opened section in Saskatchewan as the NCO I/C of the Internal Investigations Unit for the Province, in Regina. He remained within that Unit until resigning to pension from the Force in late July of 1981, accepting a management position with Saskatchewan Government Insurance Corporation in Regina, SK, as their Senior Insurance Fraud Investigator. He remained with that Corporation and in that position for 19 years, until retiring to pension in late July of 2000.

John became a Director on the *Friends’* Board in 2009 and remained on the Board until his passing. John also served on the Board of Directors of the RCMP Heritage Centre from 2007 until May of 2014. John was a talented musician and a lover of the history of the Force, serving as a docent at the Heritage Centre guiding many visitors through and explaining the many artifacts and exhibits.

John will be forever remembered and will be sadly missed.

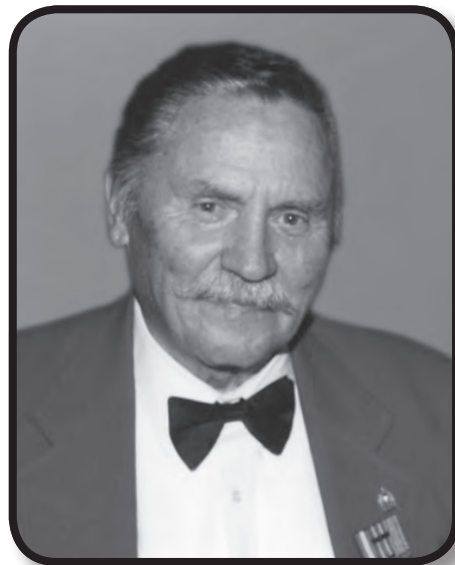
Tony served on the *Friends*' Board of Directors from 1997 to 1999.

After serving 25 years in the RCMP, retiring as Sergeant, Tony then went on to be the Manager of Loss Prevention for Western Canada for Sears Canada.

Tony was an exceptional person: a man of profound integrity, faith, tireless energy and compassion for his worldwide community along with a love and dedication for all of his family. In retirement, Tony was epitome of a true volunteer: he shared his passion for people through endless charitable work with the Lions Club, CNIB, RCMP Veterans, *Friends* of the RCMP Heritage Centre, and his church. Tony received many accolades and recognitions for his service including the Governor General's Caring Canadian Award, RCMP Veteran Association Life Membership, Saskatchewan Centennial Volunteerism Award, Lion's Club Melvin Jones Fellowship Award, and the Lion's Foundation of Canada Fellowship Award. Although the awards were appreciated, they were never why Tony gave so much of himself. Tony simply loved life, people, and his environment and wanted to leave it happier and healthier than how he had found it.

One of Tony's great passions was sharing the gift of fellowship through music with family, friends and countless strangers that heard him play at nursing homes, festivals, music jamborees, dances and backyards, both in Canada and in Texas.

Tony will be deeply missed by all who knew him.




