The President's Report

It is my pleasure to present, as President of the Board of Directors of the *Friends of the Mounted Police Heritage Centre*, the Annual Report for 2009.

Firstly, I would like to thank the Members of the Board of Directors for their support during 2009. Several projects have been undertaken and without the support of the Directors, these projects would not have materialized. I would also like to extend a hearty thank you to the Membership, in particular all those who work tirelessly to assist in the operation of the Heritage Centre and the Historical Collections Unit. Those volunteers who work as Docents, those that work as Hosts and those that volunteer in the Gift Shop. Without them, projects would still be in the planning stages. To the CEO and Staff of the Heritage Centre, I would like to express my appreciation for their cooperation and positive attitude. A smiling face makes visiting the Heritage Centre a fun place to be. To the Manager and the Staff of the Historical Collections Unit, thank you for your continued preservation of the Forces History and Traditions. To the Commanding Officers and Staff of "Depot" and "F" Division a great big thank you for your unwavering support of the Veterans Association in general, and the *Friends* in particular.

Continuing in the tradition of support for the History and Tradition of the Force, in 2009 the *Friends* have raised and donated just over \$200,000. Over \$63,000 was donated to the Historical Collections Unit, for the purchase of Display Cases, the purchase of High Density Storage Units, and the purchase of a replica 1957 Police Car.

To the Heritage Centre, on January 26, 2009, I had the privilege of presenting the CEO of the Heritage Centre a cheque in the amount of \$130,000 to be used to assist in the operation of this beautiful facility. This monetary contribution was over and above \$10,000.00 used by the Heritage Centre for various other activities throughout the year.

In total, the *Friends* have contributed over \$1,180,000.00 to the Heritage Centre and over \$2,000,000.00 to the Heritage Centre and old RCMP Museum, combined.

In continuing with the purpose of the *Friends of the Mounted Police Heritage Centre*, it is Our Pledge, as the Board of Directors of the *Friends of the Mounted Police Heritage Centre*, to continue to support the efforts of the Historical Collections Unit of the Royal Canadian Mounted Police "Depot" Division, and the Mounted Police Heritage Centre, in preserving the History and Traditions of the Royal Canadian Mounted Police.

From the Manager's Desk - RCMP Historical Collections Unit 2009 Report

The past year as been an extremely busy one for the RCMP Historical Collections Unit. We featured two temporary exhibitions in the Heritage Centre: "Scarlet Settlement" related to the March West and "In Their Own Words – 20 Years of International Peace", that recognized the service of members and other police officers in peacekeeping roles around the world.

In addition, 9 display units featuring 6 themes were developed. A majority of these were located in the lobby of the RCMP Heritage Centre and utilized the display units that the *Friends* generously purchased for us last year. These have been a tremendous asset to us, allowing us to bring more artifacts out for the public to see, and giving us the flexibility of creating displays for specific occasions. Examples are cases developed relating to members and previous members who served during WWI and WWII, as well as displays commemorating the 35th anniversary of women joining the Force.

The *Friends* also provided our Unit with high density storage racks for our textile area. These are absolutely fabulous and have allowed us to reorganize the uniforms that we have in the Collection. As well as it is allowing us the ability to maximize the use of the space we have. The additional shelving also allows us to transfer textile and sensitive objects from the main storage area into the room where there is a distinct environment specific to long term preservation of artifacts made of these materials.

We received over 450 artifact donations for the Collection over that past year. Some very notable objects include a bullet casing that was taken from the Mad Trapper's grave (during the filming of a documentary for the History channel), a Steyr Model 1886 Bolt Action Kropatchek Rifle complete with bayonet (Boer War) and Colonel Patrick Robertson-Ross' medals. Robertson-Ross was an influential figure in the eventual formation of the NWMP in 1873. We received his: Companion The Most Honourable Order of the Bath medal, The South African Campaign medal 1853, The Crimea Medal 1854, Ordre national de la Légion d'honnneur, Order of the Medjidie and Turkish Crimea Medal

A very significant acquisition was the donation of the 1957 Ford Meteor which is featured on the cover of this annual report. A very special thank you goes to Bill Greenslade and Ron Ostrum for their additional assistance on behalf of the *Friends* to make this generous gift possible, as well as to member, Terry Faye who was instrumental in bringing the car to our attention and making the potential for this donation a reality. After travelling by rail from Halifax to Saskatchewan, this car has returned to its original home (it came from a Saskatchewan dealership originally in 1957) and is now very prominently displayed in the "March of the Mounties" area in the main gallery of the RCMP Heritage Centre. This is a

real focal point of the March and has drawn a lot of attention from visitors. We have a very special thank you to the *Friends* for this extremely generous gift.

We are extremely grateful to the *Friends* for their ongoing support of the Collection and the work that we are doing to preserve and care for the RCMP's history. It is greatly appreciated by the Force overall and by our Unit in particular. Thank you again for your ongoing support and generosity.

RCMP Heritage Centre Report - 2009 in Review

On January 10, 2010 the RCMP Heritage Centre served as Regina's official send-off venue for the Olympic Torch. Over 700 people came to our wondrous Heritage Centre and participated in the celebrations. Two Troops of Cadets and several RCMP Members formed an honour guard for the torch. Elders blessed the torch as it was lit against the background of cadets in red serge and the sun coming up over the horizon. It was magic.

And that is the experience we want all of our visitors, sponsors, donors and community members to feel every time they visit our RCMP Heritage Centre – magic.

2009 was a year of change and moving the organization into the future. I started as your new CEO on March 23, 2009 and there are many new people at the Heritage Centre bringing their experience and energy to every aspect of the organization's activities. It is with pleasure that I introduce you to Shari Sokochoff, Manager of Finance and Administration; Brie Hnetka, Manager, Programs and Communication; Terry Burgess, Education and Interpretation Coordinator; Laura Haider, Coordinator, Financial Services; Melissa McDermott, Coordinator, Facility Administration; Rachel Molnar, Coordinator, Marketing and Communications; and Krista Milliken, Coordinator, Fund Development. And I am equally pleased that we still have a number of the original staff on our team: Colin Hildred, Coordinator, Information Management and Technologies; Jeff Philip, Admission Host Supervisor; Barry Temple, Manager, Retail Services; Kendra Walker, Assistant Manager, Gift Shop; and Janita Blanchard, Assistant Manager, Trading Post. This incredible team of professionals is working to make the RCMP Heritage Centre a vibrant and sustainable organization and indeed the flagship cultural and tourism attraction in Saskatchewan.

The Heritage Centre receives no operational funding from any level of government. However, it is important to acknowledge that the RCMP supports the Heritage Centre by fully covering the costs of the collection management and the Historic Collections Unit, as well as pays rent for the space occupied by the collection and the curatorial staff. The City

of Regina put payment of property taxes in abatement for five years which is a significant contribution to the financial wellbeing of the not-for-profit organization.

In 2009, the management team developed a practical operational plan and a realistic fund and revenue development plan. The fund development plan identifies a number of areas to work on with regard to enhancing our capacity to acquire donations, sponsorships, in-kind contributions, and grants from all levels of government as well as corporations' community grant programs. In addition, we are establishing a number of partnerships with colleague organizations to share costs and benefits of innovative programs and initiatives. For example, the RCMP Foundation co-sponsored the Olympic Torch Relay event at the Heritage Centre.

Other examples of partnerships with fellow cultural and tourism institutions to develop and participate in new and innovative programs and initiatives are:

- SaskArts Board resulting in an aboriginal art exhibition at the Heritage Centre;
- First Nations resulting in a Pipe Ceremony for the Olympic Torch Run in January 2010, participating in the July 6, 2010 special ceremony and contributing to programming initiatives that focus on First Nations culture;
- Canadian Heritage Information Network-Canadian Heritage resulting in a GPS pilot project of Saskatchewan history;
- Parks Canada Winnipeg Regional Office, Fort Walsh and Fort Battleford resulting in July 6, 2010 special ceremony/event;
- local museums and galleries and art centre and theatres resulting in cross promotion opportunities and joint program and special events development and delivery;
- Saskatchewan Tourism and RROC resulting in cross promotion and marketing support; partnership with University of Regina for volunteer and program development opportunities;
- partnership with City of Regina resulting in joint PR opportunities for Olympic Torch Run and other activities throughout 2010;
- partnership with RCMP Depot Division for French translation services in the operations of the Heritage Centre;
- RCMP Historical Collections Unit to offer exceptional temporary exhibitions and artifact knowledge events throughout the season.

Innovative and relevant programming is crucial for ensuring excellent visitor service, as well as fulfilling our goal of promoting the RCMP and educating community people and visitors alike about the history and honorable tradition of the Royal Canadian Mounted Police.

We are maintaining the good programs from the first two years of the Heritage Centre. However, we developed new programs to attract new audiences and broaden our reach. These new programs are receiving praise from school boards, youth organizations and seniors. A variety of bilingual school and public programming including summer day camps, weekend special events and curriculum focused activities to ensure education and visitor experience remain top priorities of the Heritage Centre. In addition, a Programming Plan for January 2010 – March 2011 and Programming Plan for 2011 are being developed.

The programs are:

- "A Pledge for Peace" Grade appropriate programming for grades K 12. All Programming aligns with Curriculum Literacy Outcomes. Tour our brand new temporary exhibition "In Their Own Words, 20 years of International Peace;"
- "Forensics 101" Grade appropriate programming for grades K-12 that aligns with Curriculum Numerousy Outcomes. Solve a mystery using forensic strategies;
- "Clearing a Path" Traditional Indigenous Art. Grade appropriate programming for grades K-12. All Programming aligns with Curriculum Literacy Outcomes. Tour the exhibition "Clearing a Path" a traditional indigenous art show presented by the Saskatchewan Arts Board. In this program students will explore the close relationship between artistic and everyday functions of traditional Indigenous art.
- "Our Treaties" Grade appropriate programming for grades K-12. All programming aligns with provincial Treaty curriculum outcomes. Students will investigate the vital relationship of the First Nations/Métis people and the RCMP. They will learn about treaties and the involvement the RCMP had surrounding treaties.
- "RCMP Heritage Centre—Outreach Program." Grade appropriate programming for grades K-12. All programming aligns with Curriculum Literacy Outcomes. An engaging and entertaining teacher from the RCMP Heritage Centre will come to your classroom with a suitcase full of interesting RCMP artifacts. They will discover the rich history and the modern day role of the Force. (Only available to schools within 45 km of Regina City limits).
- A number of other programs are in the development phase, as well as programming to celebrate the 125th Anniversary of Depot in 2010.

In addition to programs, we have hosted and participated in a number of high level events. Such participation affords an opportunity to let the community to know that this is their heritage and community centre, as well as know the Heritage Centre is serving its community and province at a provincial and national level.

Examples of the incredible special events held at the Heritage Centre are:

- Premiers Reception in August 2009
- 35th Anniversary of Women in the RCMP in September
- Official Olympic Torch Run left site on January 10, 2010
- Official launch site for the TV series on the RCMP called "Courage in Red" on SCN, in February 2010
- Celebration event of the 125th Anniversary of Depot in July 2010 in partnership

with Depot, Parks Canada, First Nations, RCMP Pipe Band and multi-cultural groups;

- Community and Stakeholder level:
 - Well attended receptions for the two temporary exhibitions: Scarlet Settlement and In Their Own Words: 20 years of International Peace
 - o RCMP Family Program and BBQ
 - o Improv and Arts Night
 - o Media Events: Tourism Saskatchewan, NWMP Trail and Red River Metis Cart , City of Regina announcing the Olympic Torch Relay event
 - o RBC, SGI Canada and other major donors' receptions
 - Volunteers Reception in November 2009, sponsored by the Friends of the Mounted Police Heritage Centre

At the Corporation level, we have re-organized the operations to enhance efficiencies and effectiveness throughout the organization. In addition, we have reviewed all contracts to tighten the operations and increase service to our stakeholders and visitors. The initial result is a saving of over \$230,000 in the next fiscal year, as well as immediate savings and improvements during the current fiscal year. And we have done a comprehensive review of financial services/systems' processes and procedures resulting in increased efficiencies and the building of an annual cycle of activities.

We conducted a comprehensive review of visitor statistics and revenue generation statistics with the result in changes in open hours on winter weekends and expanded summer hours for the next fiscal year. We are systematically developing policies and procedures to addresses all areas of operation and ensure that the organization is run according to regulations and current best business practices.

In other words, we are not only strategizing for increased fund and revenue development opportunities; we are also reviewing our organizational structure and processes to ensure efficiencies and a well run organization, and enhance customer service.

At this point of the report about the activities and well being of the RCMP Heritage Centre, I want to acknowledge the contribution of a number of people and stakeholders.

The RCMP Heritage Centre has the best volunteers. This awesome group of people always comes out for their shifts and for special events. We could not do what we do without our awesome "volunteers." Thank you!

The Heritage Centre has an excellent Board of Directors who volunteer their experience and expertise and promote the Heritage Centre across our country.

During the years 1990-2006 between \$950,000.00 and \$1,000,000.00 was donated to the RCMP Centennial Museum as recorded in the various annual reports. As well, over a period of six years and during construction, \$373,000.00 was given to the RCMP Heritage Centre Working Committee. The overall combined total to the Heritage Centre and the RCMP Historical Collections Unit is approximately \$1,050,000.00. This brings the total contribution of the *Friends* to the RCMP Centennial Museum, the RCMP Historical Collections Unit and the RCMP Heritage Centre to over \$2,000,000!
